Mail the permit and check to: New York State Liquor Authority, PO Box 782772, Philadelphia, PA 19178-2772. This permit is valid for one transaction only and requires the sale of the entire stock of alcoholic beverages in closed containers by the permittee. When the sale is approved, an inventory signed and dated by the permittee (the seller), listing the type, brand name, size and number of containers of alcoholic beverages to be sold, must be submitted to the NYS Liquor Authority. The application will be disapproved if the seller is delinquent on any payments to their wholesaler distributors.
