TO: SUMMER LIQUOR LICENSEES

SUBJECT: DISPOSAL OF STOCK OF ALCOHOLIC BEVERAGES

BY SUMMER LICENSEES

Bulletin #122, issued under date of April 16, 1945, which set forth the procedure to be followed by summer licensees at the expiration of the summer license period, in connection with their stocks of alcoholic beverages, is hereby rescinded.

To avoid working an undue hardship on licensees whose stocks of alcoholic beverages on hand at the expiration of the license period would not justify the expense of warehousing, and who are not desirous of liquidating, the Authority has ruled that such licensees may apply for and receive plenary permits. The issuance of plenary permits shall authorize such a licensee to store his remaining stocks of alcoholic beverages on the licensed premises during the interim between the expiration of one summer license period and until such time as a license is issued for the succeeding summer license period. The fee for each such plenary permit shall be one dollar (\$1.00), and each permit may authorize storage of not more than twenty (20) cases of alcoholic beverages.

Accordingly, at the end of the summer license period, licensees having stocks of alcoholic beverages on hand may (1) store the same on duly licensed warehouse premises, or (2) upon the licensed premises covered by the summer license, provided a plenary permit is secured for each twenty (20) cases of alcoholic beverages to be so stored, or (3) the stocks of alcoholic beverages may be sold under the terms of a liquidator's permit.

Whichever procedure is followed, each summer licensee must, within ten (10) days after the expiration of his summer license, submit to the Liquor Authority one of the following:

1. An application for a liquidator's permit accompanied by an inventory of the remaining stock of alcoholic beverages which shall set forth the quantity, brand name, size of containers and type of each alcoholic beverage on the licensed premises, or

- A statement containing the name, address and license number of the licensee, and setting forth the name, address and permit number of the warehouse in which such licensee has stored his remaining stock of alcoholic beverages, accompanied by an inventory of such stock of alcoholic beverages which shall set forth the quantity, brand name, size of containers and type of each alcoholic beverage, or
- An application for one or more plenary permits, accompanied by inventory of the remaining stocks of alcoholic beverages, which shall set forth the quantity, brand name, size of containers, and type of each alcoholic beverage on the licensed premises, or

In the event no alcoholic beverages remain unsold at the expiration of the license period, an affidavit setting forth that no. alcoholic beverages remain on hand and giving the name, address and license number of the licensee submitting the same.

Failure to comply with the foregoing regulations may result in the disapproval of any future application for a license by such licensee.
