If you hold a C103 Beer Wholesale License, the BC104 is not required if you will be buying cider from a wholesaler, or producer, for the purposes of retail sales. However, the BC104 is required if the C103 holder intends to sell that cider at wholesale to another wholesale license holder, or retail license holder.

APPLICATION FOR A CERTIFICATE AUTHORIZING THE SALE OF CIDER BY A BEER WHOLESALER (BC 104)

This certificate is to be used exclusively by a Beer Wholesaler

This application is to be executed by a licensed BEER WHOLESALER for a certificate authorizing the sale of CIDER by wholesale beer licensees. A wholesale beer licensee shall be permitted to sell cider at wholesale from duly licensed premises, to duly licensed beer, wine and liquor retailers and to other holders of licenses under this chapter, in bottles, barrels or casks, and to sell and deliver cider to persons outside the state pursuant to the laws of the place of such delivery.
