Instructions for Posting Notice Forms

Notice of a New Off Premises Package store

Within 10 days of filing an application (Date the application is mailed, serial # if available at time of posting) with the Authority, notice must be posted of such filing. This notice must remain posted in a conspicuous place at the entrance of the proposed establishment throughout the pending license application period.

Notice of a New On Premises Liquor Establishment

Within 10 days of filing an application (Date the application is mailed, serial # if available at time of posting) with the Authority, notice must be posted of such filing. This notice must be posted in a conspicuous place at the entrance of the proposed establishment and remain posted throughout the pending license application period. The notice shall be printed or highlighted in a pink ink of neon, luminous or fluorescent variety.

Notice of Renewal for an On Premises Liquor Establishment

Within 10 days after filing a renewal application (Date the application is mailed) with the Authority, notice must be posted of such filing. This notice must be posted in a conspicuous place at the entrance of the establishment and remain posted throughout the pending license application period. The notice shall be printed or highlighted in a pink ink of neon, luminous or fluorescent variety.

Notice of a 500 Foot Hearing

Within 10 days of the applicant's receipt of written notice (Date of hearing notice) of a 500 ft hearing, notice must be posted of such hearing. This notice must be posted in a conspicuous place at the entrance of the establishment and will remain posted until the date of the hearing specified on notice. This notice shall include in clear and concise language a statement of the use and capacity of the establishment.
