



APPLICATION FOR A TEMPORARY WHOLESALE PERMIT OR EXTENSION OF A TEMPORARY WHOLESALE PERMIT; INCLUDING IMPORTER'S PERMITS & BRAND OWNER PERMITS

Section 97-d of the Alcoholic Beverage Control Law authorizes the issuance of a temporary wholesale permit to allow applicants for wholesale licenses to operate while the license application is pending. The initial permit is valid for a six (6) month period. The fee for the initial permit is \$125.00. The fee for the permit is in addition to the fee required for the license. The temporary permit can be extended for a three (3) month period, at the Authority's discretion, for an additional \$50.00 and with the submission of this application form. Each extension requires the payment of the permit fee and the submission of this application form.

YOU ARE ELIGIBLE FOR THIS PERMIT IF:

- (a) you have a wholesale license application (including importer & brand owner) pending before the liquor authority; or
(b) you have filed this application simultaneously with an application for a wholesale license; or
(c) you have obtained the necessary TTB approval to operate your wholesale business.

A temporary wholesale permittee can perform the same activities that are allowed under the wholesale license.

APPLICANT STATEMENT

I understand that failure to give such notice may result in disapproval of the application or revocation or non-renewal of any license for which this application is submitted; and

I understand that the licensee will be bound by the statements and representations made in the application, including, but not limited to the licensee's method of operation and the identity of persons with an ownership or financial interest in the licensed premises; and that all statements and representations made become conditions of the license; and

I understand that any physical alterations to, or changes to the size of the area used for the sale and consumption of alcoholic beverages, must be reported to the Authority and may require the approval of the Authority; and

I understand that the licensee must keep the Authority advised of any change in the mailing addresses of the licensee, the licensee's principals, and the licensee's landlord.

I understand that the licensee's failure to operate the licensed premises in accordance with the statements and representations made in the application may result in revocation of any license for which the application was submitted; and

I understand that any false statement or misrepresentation will constitute cause for disapproval of the application or revocation or non-renewal of any license for which this application is submitted.
